

Privacy Policy For SOFF Cricket Facility

TOGETHER, THESE WILL BE REFERRED TO AS THE “SOFF CRICKET PLATFORM”. BY ACCESSING, BROWSING AND USING THE SOFF CRICKET PLATFORM, YOU INDICATE THAT YOU HAVE READ AND ACCEPT THE PRIVACY POLICY AND TERMS OF SERVICE.

This privacy policy explains how we collect, use, disclose and protect the personal information provided by our customers and users through the SOFF Cricket platform. We may collect personal information to allow you to book services and make purchases on the platform, and improve our service.

Terms of this Privacy Policy are subject to change without notice, from time to time in our sole discretion. We will notify you of amendments to these changes by posting them to this website. If you do not agree with our Privacy Policy and our Terms and Conditions, please do not access the SOFF Cricket platform.

Disclaimers

Security: We have implemented administrative, technical, and physical security controls that are designed to safeguard Personal Information. However, no online activity is ever fully secure or error-free. While we strive to protect your information, we cannot guarantee that your Personal Information is absolutely secure. Please keep this in mind when disclosing any information to SOFF Cricket.

Data Retention: We will retain your Personal Information for as long as your account is active or as needed to provide you services and to maintain a record of your transactions for financial reporting purposes. We will also retain and use your Personal Information as necessary to comply with our legal obligations, resolve disputes, and enforce our agreements.

Third-Party Sites: Some of the functionality may be provided by third parties and the services may link to other third-party websites that are not controlled by SOFF Cricket.

These third parties are not under our control and we are not responsible for their privacy policies or practices.

Social Media Usage: You may choose to enable or log in to our platform via various online services, including social networking services like Facebook and Google. When you link a Social Network account to GangFy Auto or log in to our services using your Social Network account, we may collect relevant Personal Information necessary to enable our services. We also may share your information with the operator of that Social Network to facilitate or enhance the delivery of that Social Network or other services to you.

What We Collect

Information provided directly: This information may include your User Profile (Includes information such as name, email address, delivery address, and phone number), and Payment Information (Includes bank name and payment method).

Information received via communications: When you use the platform, complete electronic forms, communicate with vendors or contact us, by online chat, email, phone or text, we may automatically collect and store certain information about you and the activity you engaged in.

Information collected automatically: This may include Technical Information (Information associated with your activity on our platform which may include information related to your browser and operating system, IP address, unique device identifiers, and other information such as your device type. We use such information for diagnostic and statistical purposes and to administer our services), Site Usage Information (This may include the webpage that you were visiting before accessing our platform and the pages or features of our platform you browsed. This information is used to analyze and improve our platform and to provide our customers with a better user experience), and Platform Preferences (Information about your preferences to make your use of the platform more productive through the use of cookies). We also use "cookies" or other tools that track, measure and analyze the behaviours and usage patterns of visitors to the platform.

Personal information from publicly available sources and third parties: This may include Social Network Information and Demographic Information (This could include information such as income, marital status, spending habits, and other information pertaining to customers).

Surveys: From time to time, SOFF Cricket may conduct online surveys for internal purposes or for third parties, to gather general information about users and/or their views. Participation in these surveys is voluntary; no information will be collected except that which is knowingly supplied by the user. Identifying Personal Information will not be shared.

How We Use It

To provide you with our services: If the applicable information is to be provided for the service to be performed by a third party, then we will disclose the applicable Personal Information to the third party who is contractually obligated to protect your information as disclosed in this Policy.

To maintain, improve and personalise our services: We use your information for our everyday business operations such as auditing, administration of the services, forum management, fulfilment, and analytics. Your information may also be used to improve the content and/or functionality of the services. In addition, we may personalize advertisements, marketing communications, and recommendations to make them more tailored to your interests.

To communicate with you: We may send you text messages or other notifications about the status of your bookings and membership. We may also contact you with promotional offerings or other communications that may be of interest to you.

For Account and Network Security purposes: Keeping you safe requires us to process your Personal Information, such as your device information, activity information and other relevant information. We use such information to combat spam, malware, malicious activities or security risks; improve and enforce our security measures; and monitor and verify your identity so that unauthorized users do not gain access to your information.

For our business purposes: We may use your information for any other purpose disclosed to you at the time we collect or receive the information, or otherwise with your consent.

Who We Share With

Your Personal Information is not shared with third parties without your permission, except as described below.

Service Providers: This information is provided in order for them to provide us services such as payment processing, advertising services, marketing partners, web analytics, data processing, IT services, customer support and other services. These third-party service providers have access to your Personal Information only for the purpose of performing services on our behalf and are expressly obligated not to disclose or use your Personal Information for any other purpose.

Related Entities: We may share your information with our affiliates for business purposes. We will require these entities to comply with the terms of this policy with regard to their use of your information.

With your consent: We also may share or disclose your information with your consent or at your direction.

Our Rights To Manage Your Personal Data

Accuracy of data: We will always try to ensure the data we hold about you is accurate and relevant. If you believe the information we hold about you is out of date or incorrect, please tell the management or see the contact us section below. You will need a form of identification to request any changes.

Seeing your data (Subject access request): You have the right to know what personal information we hold about you. This is called a Subject Access Request.

Removing your data: If you no longer use our services and products and wish us to delete your personal data we will do this if there are no legal or statutory regulations requiring us to keep this information.

Objection to processing: You can object to the processing of your data in certain circumstances such as marketing.

Withdrawing consent: If we are relying on consent to process your data, you may withdraw your consent at any time by contacting us.
